

Subject:- 12th AMENDMENT IN THE BALOCHISTAN CIVIL SERVANTS' PROMOTION POLICY-2012.

"provided that civil servants against whom an inquiry, investigation, case or a reference is pending in Anti-corruption Establishment, Federal Investigation Agency, National accountability Bureau or such other organization by whatever name called for, more than three (03) years and the delay has not been caused by any reason attributable to the officer, may be recommended for promotion".

2. The Administrative Departments are requested to strictly adhere to the aforesaid amendment/insertion and also bring into the notice of the all Attached Departments/ Subordinate Offices, under their administrative control for compliance.
