NOTIFICATION

[14th December, 2011]

No. S.O (R–I) (5)2/2011-S&GAD/6160-3260. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following rules, namely:—

- 1. <u>Short title, application and commencement.</u>—(1) These Rules may be called the Balochistan Government Servants (Marriage with Foreign Nationals) Rules, 2011.
- (2) They shall apply to every person who is a member of a service of Government of Balochistan or who is serving in a civil capacity in connection with the affairs of the Provincial Government, but shall not apply to any person who is employed on contract basis.
 - (3) They shall come into force at once.
- 2. **<u>Definitions.</u>**—(1) In these Rules, unless there is anything repugnant in the subject or context,—
 - (a) "Act" means the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974):
 - (b) "Antecedents of the case" means all the relevant documents required for the purpose.
 - (c) "Competent Authority" means the authority competent to allow a Government Servant for marriage with Foreign National under these rules, and as specified under rule 5;

These rules have been issued by the Services and General Administration Department, Government of Balochistan, vide its Notification No. S.O (R–I) (5)2/2011-S&GAD/6160-3260, dated 14th December, 2011; and published in the Balochistan Gazette (Extraordinary) No. 10, dated 14th December, 2011.

- (d) "Foreign National" means a person who is not a citizen of Pakistan within the meanings of the Pakistan Citizenship Act 1951 (Act No. II of 1951);
- (e) "Government" means the Government of Balochistan;
- (f) "Government Servant" means a person in the service of Government of Balochistan to whom these rules apply;
- (g) "Home Department" means the Home and Tribal Affairs Department of the Government of Balochistan;
- (h) "Marriage" means matrimonial relationship entered into in accordance with any law for the time being in force or any religious rites or ceremonies, and its grammatical variations and cognate expressions shall be construed accordingly;
- (i) "Prescribed" means prescribed by rules made under these Rules;
- (j) "Rules" means Balochistan Government Servants (Marriage with Foreign Nationals) Rules, 2011;
- (k) "Schedule" means Schedule attached to these Rules; and
- "Services and General Administration Department" means the Services and General Administration Department of the Government of Balochistan.
- 3. Marriage with Foreign Nationals prohibited. (1) Subject to the provisions of sub-rule (2), a Government servant who marries or promises to marry a Foreign National shall be guilty of misconduct and render himself liable to remove from Service under the Balochistan Employees' Efficiency and Discipline Act, 2011 or any other law/rules for the time being in force.
- (2) A Government servant may, with the permission of the Government, marry or promise to marry a Foreign National of any Country recognized by Federal Government.
- (3) The grant of permission under sub-rule (2) shall be at the discretion of the Government and may be subject to such conditions, if any, as it may prescribe.
- 4. **Procedure for applications and permission thereon.** (1) All applications for permission under sub-rule (2) of rule 3, shall be submitted on the form set out in the Schedule, to the concerned Administrative Department or the Regional Head, as the case may be, where under the applicant is serving in the service of Government.

(2) On receipt of an application under sub-rule (2) of rule 3, the Administrative Department or the Regional Head, as the case may be, shall forward the same to the Home Department.

(3) On receipt of applications from the Administrative Department or the Regional Head, as the case may be, the same shall be scrutinized and antecedents verified by the Home Department in consultation with Special Branch of Police Department or other State Agencies at Provincial or Federal level or the Interior Ministry of Pakistan, as the case may be, for making recommendations to the Services and General Administration Department for approval of the Competent Authority.

(4) The Home Department after due scrutiny as per sub-rule (3) furnish its recommendations in a confidential manner to the Services and General Administration Department, which shall be submitted for orders/approval to the Competent Authority by the concerned Section of the Services and General Administration Department.

5. <u>Competent Authorities to approve the recommendations.</u> The Authorities Competent to approve the recommendations shall be as follows:-

In basic pay scales-16 and above
In basic pay scales 1 to 15.

6. <u>Supersession of previous rules, notifications, etc.</u> These rules shall supersede all previous rules, notifications and instructions issued by the Government, relating to the conditions of marriage of a Government Servants with Foreign Nationals.
