(a) 50% by promotion from amongst the members of the Service holding the post of Comptroller VIP-Flats S&GAD (BPS-18) having at least twelve (12) years' service in BPS-17 and above, and have successfully completed Mid Career Management Course, on seniority cum fitness basis. If for any reason the post falls vacant

and no suitable officer is available in the promotion zone, then the post shall be filled by transfer/ posting from amongst the S&GAD officers of BPS-19 under section-10 of the Balochistan Civil Servants' Act, 1974 read with rule 11 of the Balochistan Secretariat Posts) (Miscellaneous above) (BPS-16 and Service Rules, 2016; and promotion (b) 50% by from amongst the members of the Service holding the post of Director Deputy (Estate) S&GAD (BPS-18) having at least years' (12)twelve service in BPS-17 and above, and successfully completed Mid Career Course, Management on seniority cum fitness basis. If for any reason the post falls vacant and no suitable officer is available in the promotion zone, then the post shall be filled by transfer/ posting from amongst S&GAD officers of BPS-19 under section-10 of the Balochistan Civil Servants' Act, 1974 read with rule 11 of the Balochistan Secretariat (Miscellaneous Posts) (BPS-16 and above) Service Rules, 2016.
