NOTIFICATION

No.SOR-II(22)48/2016-S&GAD/1345-61. In exercise of powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is please to make the following amendments in the Balochistan Civil Service (Executive Branch) Rules, 1984, namely:-

In the aforesaid rules, in rule-5,-

(i) in sub-rule-3, for clause (a), the following shall be substituted,-

- (a) 87½ percent from amongst the members of Balochistan Tehsildari Service whose names appear in the Select List "A" to be maintained in accordance with the provision of Clause (a) of sub-rules-(4); with at least three (3) years service as such and also passed the departmental examination; with Bachelor's Degree or sixteen years' of Education. The condition of Bachelor's Degree or 16 years of education is relaxed on attaining the age of 55 years;



Provided that the period of probation and training shall not be counted towards length of service for the purpose of promotion; and

(ii) in sub-rule-4, for clause (b), the following shall be substituted:-

- (b) as and when the post becomes available to be filled by promotion under clause (b) of sub rule (3), the same shall be circulated for inviting applications to be received within 15 days of the date of circular letter from amongst the following categories of employees, having at least three (3) years' service as such for those who holds substantive post of BPS-17, and for the incumbent holding BPS-16 post at least five (5) years' service as such. Upon receipt of applications the S&GAD shall prepare a Select List "B" in accordance with the Form 2 appended to these rules, within one (1) month of the last date of application; and possessing Bachelor's Degree or sixteen years of education. The condition of Bachelor's Degree or 16 years of education is relaxed on attaining the age of 55 years:-

(i) BALOCHISTAN SECRETARIAT SERVICE

- (1) Private Secretaries (BPS-17);
(2) Superintendents (BPS-17); and
(3) Assistant Private Secretaries (BPS-16); and

(ii) COMMISSIONER'S OFFICES.

- (1) Private Secretaries (BPS-17);
- (2) Superintendents (BPS-17); and
- (3) Assistant Private Secretaries (BPS-16); and

EXPLANATION:

The promotion against ministerial quota from the above mentioned Select List "B" shall be made on merit-cum-fitness basis/PERs synopsis and ability to hold the higher post. The applicants will have to provide their C.Vs/Bio-data and regular promotion Notifications alongwith their applications.
